## CREDIT APPLICATION TERMS AND CONDITIONS

1. In the event of the Banana Shire Council granting credit facilities to the Applicant, then the applicant shall settle all accounts in full no later than 30 days from the date of issue or not later than the due date shown on the invoice.
2. Granting of credit to an Applicant will only be on receipt of a fully signed and completed application and satisfactory assessment and evaluation.
3. The applicants acknowledge that under Section 18(E)8(c) of the Privacy Act, the Banana Shire Council is allowed to give a credit reporting agency personal information about the credit application. The information, which may be given to an agency is covered by Section 18E(1) of the Act.
4. The applicants agree that the Banana Shire Council may, if it considers relevant for the purpose, obtain from a credit reporting agency, credit reports containing personal credit information about the individuals:
  - To assist assessment of the individual's application for commercial credit
  - To assist in collection of overdue payments (Section 18K(1)(b) & (h))
  - To assess whether to accept the individuals as guarantors for credit applied for or provided to the Applicant.
 The individuals agree that if the Banana Shire Council approves the Applicant's request for credit, this agreement remains in force until the credit facility covered by the application ceases (Section 18K(1)(c)).
5. The applicant will not be granted credit before the application has undergone the Banana Shire Council's credit assessment and received approval.
6. Where credit accounts are overdue by 30 days or more, the credit facility may be withdrawn and the debt may be referred to a credit reference agency as a defaulted payment.
7. Banana Shire Council has the right, at its discretion, to charge interest at a rate of 11.00%pa for any overdue accounts.
8. Banana Shire Council has the right, at its discretion, to cancel any credit facility at any time. In the event of any credit facility being cancelled, for whatever reason, the monies due to the Banana Shire Council shall become due and payable immediately upon demand.
9. In the case that the Applicant shall be a Company acting as a trustee for a trust, the Applicant hereby acknowledges that the trust shall be liable on the account, and the trust has sufficient assets to meet payment of the credit facilities granted.
10. The Customer will notify the Banana Shire Council no later than 14 days after any changes of ownership or change in particulars.
11. Any expenses, costs or disbursements incurred by Banana Shire Council in recovering any outstanding monies, including debt collection agency and solicitors fees, shall be paid by the Customer.
12. Any payments tendered by the Customer to the Banana Shire Council shall be applied as follows:
  - Firstly, as reimbursement for any collection costs by Council
  - Secondly, as payment of any interest charged to the Customer
  - Thirdly, in satisfaction or part satisfaction, of the oldest portion of the Customer's account.

### Additional Terms and Conditions - Trap Gully Landfill

1. Only customers who hold an account with Banana Shire Council can dispose of waste at Trap Gully Landfill.
2. Only waste generated within the Banana Shire will be accepted at Trap Gully Landfill.
3. Council will only invoice the company or individual disposing the waste, not a third party.
4. The only waste accepted at Trap Gully Landfill is commercial waste, liquid waste (grease trap only), clean building rubble, regulated waste and asbestos (by prior arrangement only), recyclable metals, clean fill, dead animals and tyres. Please refer to Council's fees and charges for waste disposal fees.
5. A call out fee will be charged if disposal is required out of normal operating hours.
6. Disposal is only to be carried out under the instructions of Trap Gully Landfill operators. Failure to comply may result in discontinue use of Trap Gully Landfill.
7. Failure to pay invoices on time may result in your Trap Gully account being suspended or withdrawn.
