## NOTE

#### **GIFT**

- A Gift also includes a number of gifts totalling the relevant dollar figure
- A gift is not necessarily money or an object the definition includes "other benefit"

### SPONSORED HOSPITALITY BENEFIT

What appears to be a hospitality benefit may actually be a Gift if no travel or accommodation is involved. For example attendance at a club dinner where the meal and/or drinks are supplied at no cost is a Gift.

#### REGISTERS

- All registers may also be inspected by "Another person permitted by law to have access to information in the register" e.g. CCC
- Registers must be updated within 5 business days of the Gift and Sponsored Hospitality Declaration Form being received
