# Property Search Information Fact Sheet

## Rates and Water Searches

#### Rates Search -

Short Rate Search – Property details, rate position for the current financial year and rates and charges information.

Full Rate Search – Property details, rate position for the current financial year, water meter readings, water, sewerage and/or septic connections information, rates and charges information, registrations/licenses required, outstanding requisitions and notices, zoning/preferred land use under Town Planning Scheme, building information, re-alignments, resumption, easements/service lines and if the property is identified within the Qld Floodplain Assessment Overlay. Rural properties will also receive the information provided in the Rural Lands Records Search detailed below.

Urgent Rate Search - Same information as a Full Rate Search, completed within 3 working days of payment.

Phone/Counter Search - Name and contact details of property owner.

Water Meter Reading - Property details, water meter readings and water and sewerage connection information.

# Water and Sewer Searches

Water Meter Re-Reading – A council officer will physically re-read the water meter located on the property. This fee is refundable if six monthly read is incorrect.

Water & Sewer Location Search - see plans description below.

Technical Water & Sewer Location Search – A Council Officer will locate approximate depth & alignment of Sewer & Water Main onsite.

## Planning and Development Certificates

The provision relating to **Planning and Development Certificates** is outlined in section 265 of the *Planning Act 2016*. It is recommended that any prospective purchaser or future owner contact Council's planning department to discuss possible land use requirements for this property.

# **Plans**

Sanitary Drainage Plan - This outlines the house drainage for a property. Please note this plan is included in the Plumbing Records Search.

**Water & Sewer Services Plan** – This plan outlines Council's Water and Sewer Infrastructure from Council's mapping system. \*\*Please note these plans are to be used as a guide only and pothole testing should be used when excavating around the areas of any Council Infrastructure.

# **Building and Plumbing Searches**

Building and Plumbing Search - provides details and copies of permits and final certificates issued including certificate of classification.

Certificate of Classification - Council will provide a copy of an existing certificate of classification (included in building record search).

**Pool Safety Certificate Inspection** – provides confirmation that pool\spa complies with legislation which commenced 1 December 2010. Fee includes one inspection only; if re-inspection is required additional charges will apply.

#### Health and Environment Searches

**Health Compliance Search** – may take up to 10 clear working days to complete. Compliance searches will not be conducted until payment for service is received.

Environmental Activities – The following are defined as environmental activities under the Environmental Protection Act 1994.

Asphalt manufacture, Boat maintenance or repair, Metal forming (ie panel beating, construction of steel tanks) > 10,000 t/year, Metal recovery (ie scrap metal yard, wreckers), Plastic product manufacture > 5t/year, Surface coating (ie anodizing, enameling, electroplating, galvanizing) 1-100t of surface coating material/year.

Food Premises includes any premises, mobile operation or vehicle where the following are performed:

Café, Cafeterias, Cannery, Canteens, Caterer's Premises, Clubs, Coffee lounges, Cordial or softdrink factory, Drink/Milk Bars, Delicatessens, Fruit Shops, Hotels, Kiosks, Mobile food vendors, Motels, Provision stores, Restaurants, Sandwich shops, Snack bars, Take-aways, Tuckshops.

**Skin penetration** includes any premises, mobile operation or vehicle where the following are performed:

Body piercing; Tattooing; Scaring or cutting; Implanting hair, beads or the likes.

**Shared facility accommodation** includes accommodation provided for holiday makers or travelers on the basis of residents sharing 1 or more of the following: dormitories, toilets, bathrooms, laundries, or dining, cooking or recreation facilities. Shared facility accommodation does not include: a hotel/motel, public housing, hospital/nursing home, residential college or boarding house, religious institution, community title scheme, or private home with no more than 3 boarders.

**Other business types** include, but is not limited to, businesses or premises which are associated with Footpath dining, Advertising signs, Public health risks.

Rural Lands Records Search – searches Council's records for the existence of any orders issued under the *Biosecurity Act 2014*, the *Stock Route Management Act 2002* or the former *Land Protection (Pest & Stock Route Management) Act 2002* which affects the property listed.
