BURIAL ON PRIVATE PROPERTY CRITERIA: Burials on private property will only be permitted where the following criteria have been met	<ul> <li>The applicant must be able to satisfy the requirements of Council's Local Law No. 1 (Administration) 2011;</li> <li>The property must be freehold;</li> <li>The property must be no smaller than 40 hectares in size;</li> <li>The applicant must have a family association with the property of at least 50 years;</li> <li>The applicant must agree to have a note placed on the rating database that a family grave is located on the property;</li> <li>Prior to any burial, advise Council of the Funeral Directors details;</li> <li>Burials in vaults must meet the requirements of Schedule 15 of Councils Local Law 1 in particular; <ul> <li>Anybody interred in a mausoleum or vault must be enclosed in a hermetically sealed or other industry accepted shell.</li> <li>Provide a copy of the design for the vault.</li> </ul> </li> <li>After an interment the following additional conditions are to be met:- <ul> <li>Within 12 months fence off the grave area;</li> <li>Within 12 months install a grave marker on the grave; and</li> <li>Provide Council with the GPS coordinates of each grave, which will be placed on the GIS database.</li> </ul> </li> </ul>
